Office Order No. 3E-17-01 : 2193 /Dt. 28.7.03

In pursuance of the decision of the High Power Committee in its meeting held on 30.6.03 and the guidelines issued by the Govt. in the Deptt. of School & Mass Education, Orissa, BBSR vide Resolution No. 30720/SME dt. 23.9.96, No Objection Certificate is granted in favour of **Delhi Public School, Adhalia, Phulnakhara, Cuttack**

to open an un-aided Primary School upto class VII which is to be affiliated to the ICSE/CBSE subject to the following terms and conditions.

1. The "No Objection Certificate" now issued shall be subject to the terms and conditions as prescribed in the GO No. 30720/SME dt. 23.9.96.
2. Medium of instruction in the School shall be English but Oriya as a subject shall be taught to all pupil in the institution compulsory.
3. The School shall be open for inspection by the Inspection Committee.
4. No financial assistance and grant in aid (both recurring and non-recurring) will be claimed by the institution from the Govt. at any point of time for meeting the salary cost and its component towards teaching and non-teaching staffs appointed by the Managing Committee.
5. The M.C. of School will not shift the present location of the School without prior approval of Director, Elementary Education, Orissa.
6. The High Power Committee shall be competent to review the NCC granted to the institution concerned and shall be competent to withdraw the same if the terms and conditions contained in the GO no. 30720/SME dt. 23.9.96 shall be violated at any time.
7. The Managing Committee shall be constituted in accordance with the Section-7 of the Orissa Education Act, 1969.




